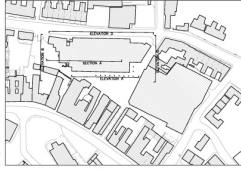

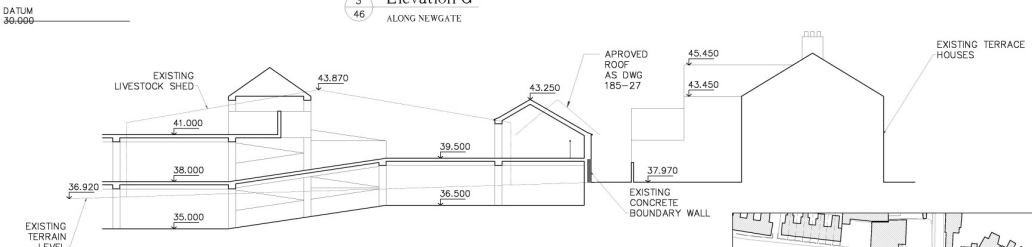
1 Elevation E

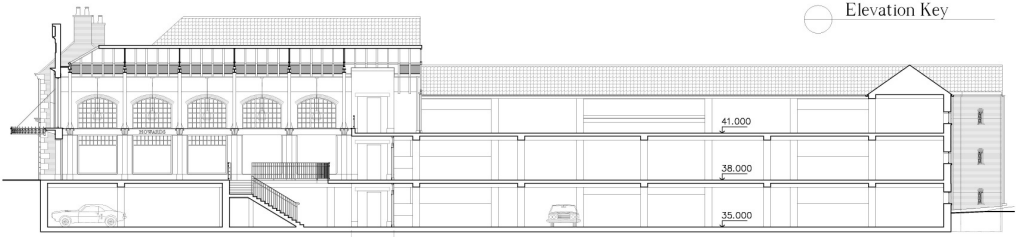
