MINUTES OF MEETING HELD ON 1/09/2015

Minutes of the previous meeting were presented, agreed and signed as a true record.

Matters arising: The flooding of the gully at Scampston has now been rectified – Yorkshire Water discovered two leaks in the pipe and repaired these. The Declaration of Acceptance form has now been completed and forwarded to RDC by Cllr Piercy. One is still outstanding.

Accounts: Cheque raised value £120 re grass cutting. The latest Bank Statement was viewed and discussed. Reimbursed £20 by Scampston Estate for hire of village Hall. Remittance advice received from RDC re grass cutting.

Planning: Re erection of single storey to Leawood, Scampston – no objections.

A representative six residents of West Knapton attended the meeting to discuss several major issues regarding the planning application by Boormalt for expansion at W. Knapton Silo. It transpired that several major issues have arisen regarding smell, dust and noise. These were not apparent on the original plans and the Chairman has agreed to write to RDC putting forward the multiple problems and requesting further investigations.

Correspondence: Letter received from a resident in Scampston re the flooding (of rainwater) of the road between Plains Farm and Rillington Manor and draws attention to the previous gullies which appear to have been blocked. Clerk to investigate. YLC Ass. Annual review. NY Fire & Rescue Auth Re consultation conclusion date of 16th October 2015 for organising of its resources for responses to fires etc. Leaflet from RDC on A Guide to Procedures for planning committee meetings. Winter service grit bins – NYCC have omitted the inclusion of W. Knapton, the Clerk to contact NYCC. The remaining correspondence was discussed and acted upon.

AOB - Potholes in front of Lucus Cottage at E. Knapton, and road cracked outside of bus stop on the A64 at W. Knapton. The village sign at W. Knapton has been damaged and Cllrs Webster and Byas have agreed to attend to this.
