Purchase of an innovative replacement CCTV system for Malton, Norton and Pickering monitored 24/7 by Scarborough Borough Council, which will include 7 cameras in Malton, 4 in Norton and 3 in Pickering town centres.

The equipment will aim to protect the community of Ryedale by providing reassurance and confidence to members of the public, maintain public order, reduction of anti-social behaviour and nuisance. Members of the business community will have added security and promotion of economic well being.

The equipment will send a clear message to those engaged in crime or anti social behaviour that they will be caught and prosecuted by providing clear evidence to enforcement agencies.

The CCTV equipment, Police and relevant agencies will work in partnership together to tackle problems associated with community safety and crime, thereby, making the market towns of Ryedale future proof. If a criminal act or vulnerable person is observed on a camera, CCTV operators will have the ability to direct Police response to the incident.

Why is the project needed?

The existing CCTV equipment is now dated, not fit for purpose and viewing is limited. North Yorkshire Police are now operating in a different world and tackling hidden crimes using new technology. The Street Angel project which supports local Police in the night time economy will be able to continue and expand to Pickering.

The Safer Ryedale Partnership Plan 2017-18 Aim 9 - To review and update CCTV capabilities in Ryedale working with Ryedale Cameras In Action and Scarborough Borough Council. Support from St Michael's church has been obtained with approval from Diocese for discrete CCTV antennae which will be mounted on the church roof. The Street Angels are only insured to operate with the support of a monitored CCTV system, the successful project will also expand to Pickering once CCTV equipment has been reinstalled. Ryedale Cameras In Action are part of the North Yorkshire CCTV Forum chaired by Deputy Chief Constable Lisa Winward who support this project.

By working in partnership with other agencies, driving innovation forward and protecting the most vulnerable people in our community, the project will reinforce local policing, provide additional public protection and community safety.
