## 2.MINUTES.

# **3. MATTERS ARISING**

# 3.1. NORTH YORKSHIRE MOORS NATIONAL PARK AUTHORITY LOCAL AUTHORITY PLAN

Cllr. Statham reported that a reply to questions put to the NYMNPA on behalf of the Parish Council was received from Chris France (Director of Planning). This response provided reassurance to the Parish Council that the draft plan process would provide protection from unwanted development in our parish. Cllr. Statham remarked that, given the ambiguity of the process as it had developed, this was a welcome outcome.

## **3.2. PARISH PORTAL.**

Mrs Clark informed the meeting that the Parish of Byland with Wass and Oldstead was still unable to connect to the Parish Portal to report highway faults and the matter had been referred to North Yorkshire County Council by Area4 (Highways Department).

Mrs. Clark is to resolve this matter – if it cannot be resolved the County Councillor will be made aware of the problems.

## 3.3. WATER TREATMENT WORKS OLDSTEAD

Cllr. Gibson outlined the problems that may arise if residents remove septic tanks in Oldstead. These include the risk of river pollution and blockage of drainage pipes. This is an ongoing matter of concern – Cllr. Gibson may contact Yorkshire Water at a later date if it is appropriate.

## 3.4. DELIVERIES TO THE BLACK SWAN RESTAURANT

The problem of noise caused by early morning deliveries has been resolved.
