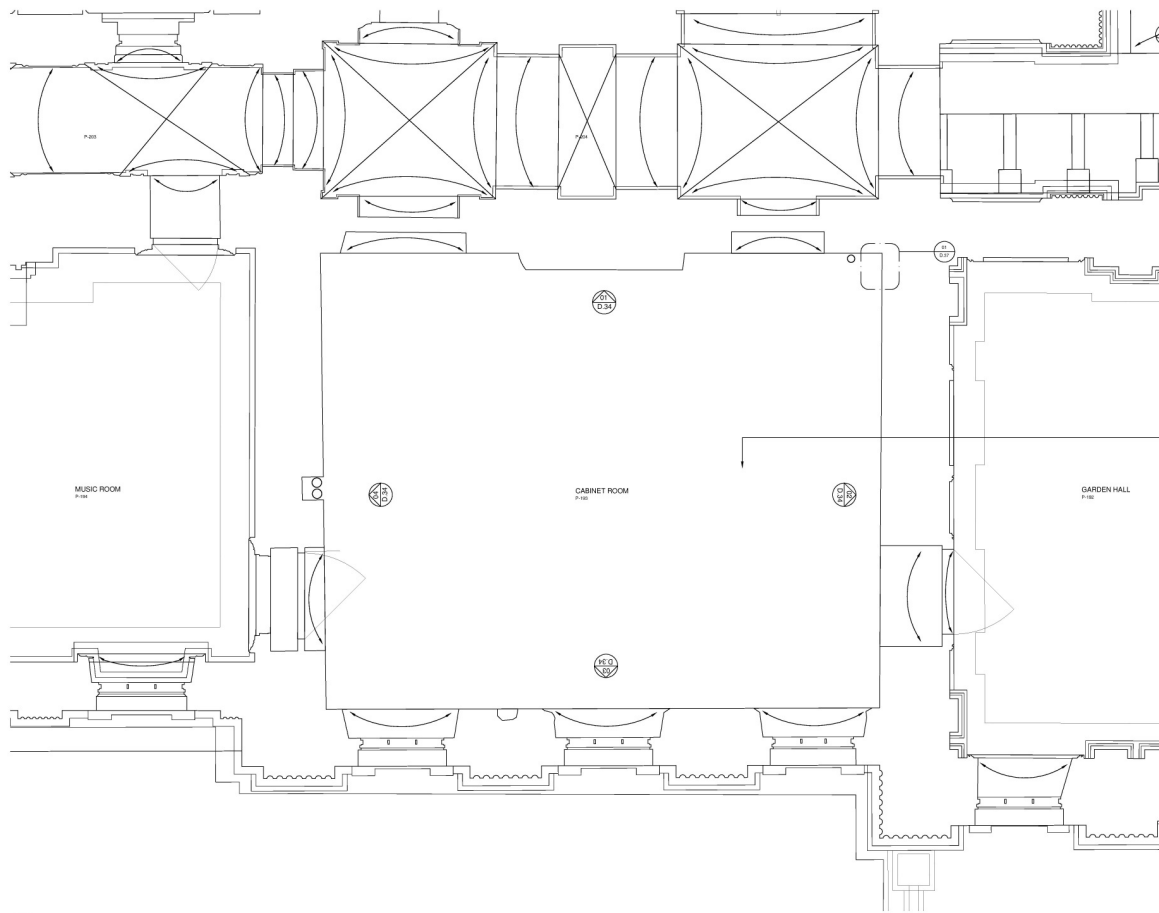

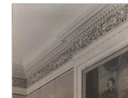

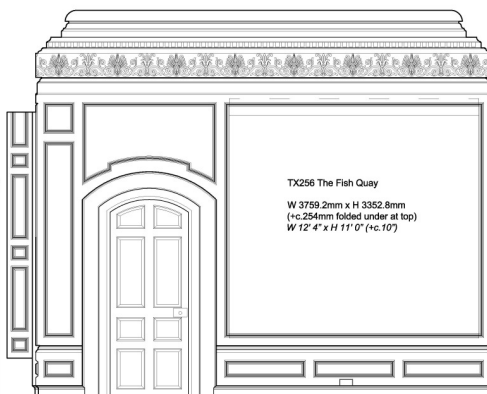
01 NORTH ELEVATION WITH CHIMNEY PIECE DESIGN OPTION 1 - AS PROPOSED

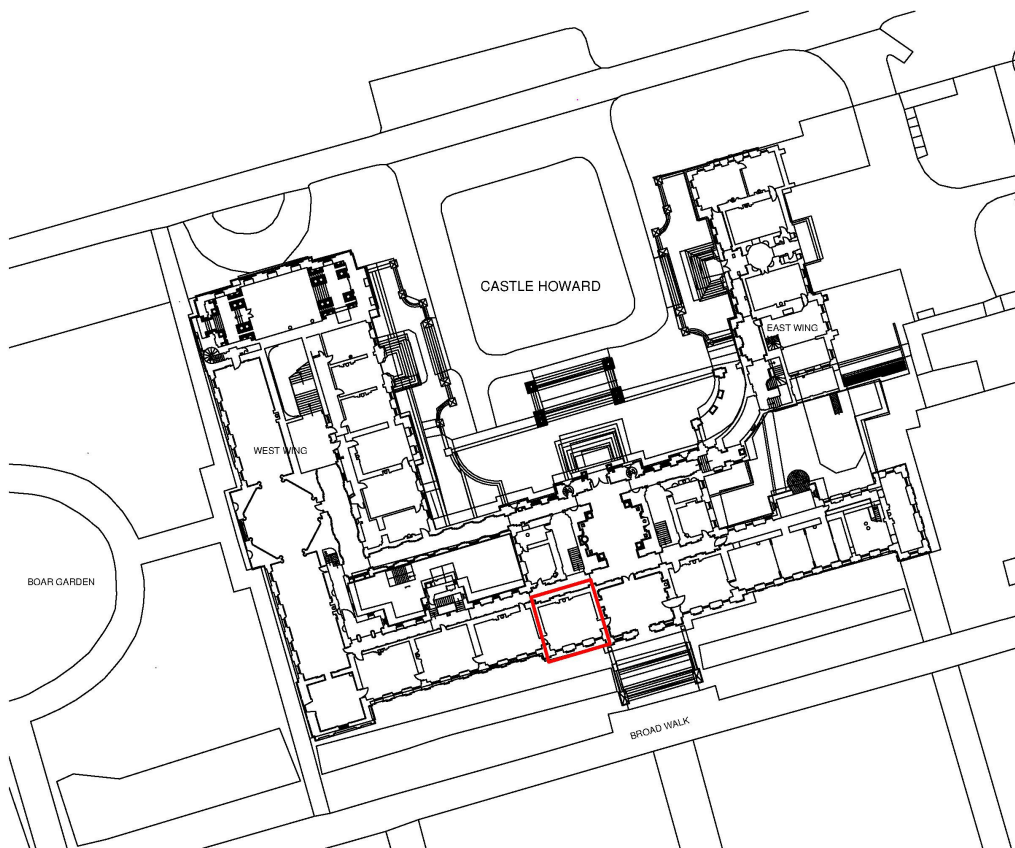

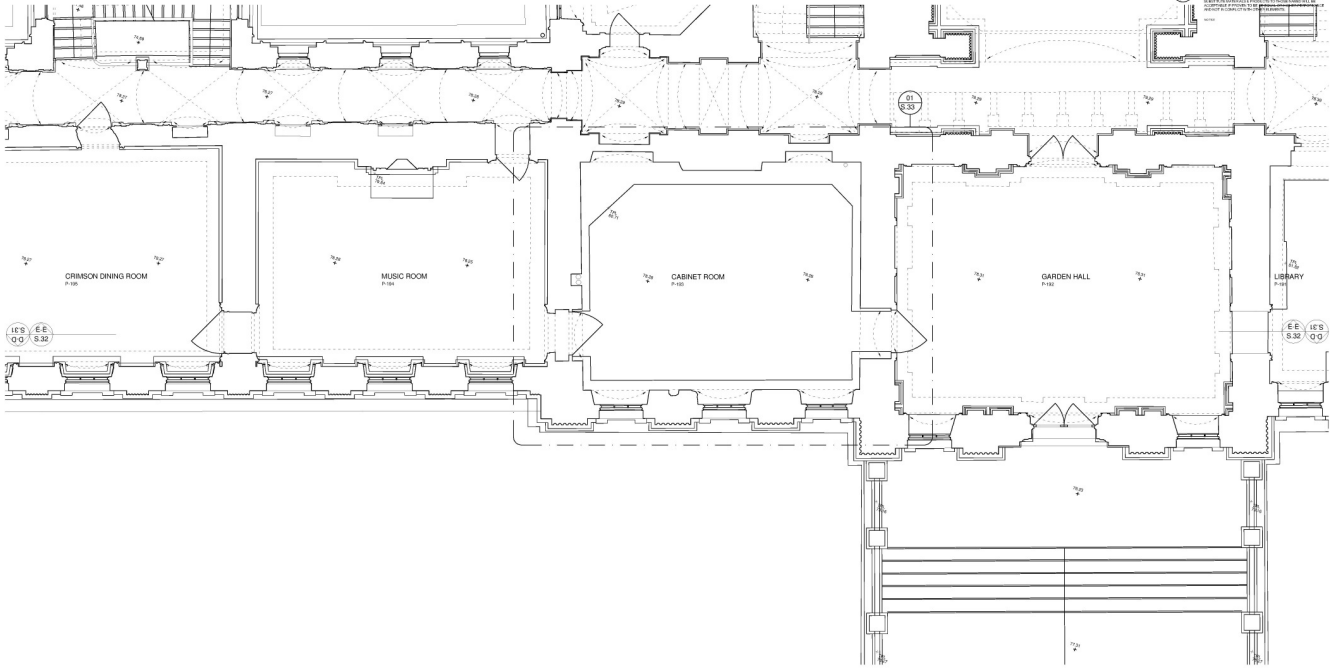

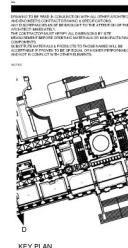
