Formal complaint

I am extremely concerned about the minutes that I have been provided of the meeting, and the representations that were made to me about this being related to outline access permission only. I specifically called yourselves and enquired as to the nature of this application as it was unclear and was subsequently informed by your representative (a male on the telephone) that this was relating to the access change from a single point of access to two points of access. This was therefore the basis of my representations and I specifically noted this due to being advised as such in my letter.

My only assumption is that it was simply worded in such an unclear way as to what exactly was being applied for that your advisor misinformed me when I called to ask for clarity. As such I have been misled in my ability to make an accurate and informed stance on the matter. I believe this is a failure to properly consult on the application made.
