Apologies: Apologies for absence were received from Mrs. R. Farrdale.

Minutes: The Minutes of the last Meeting held on the 15<sup>th</sup> September 2021 having been circulated to all Members were signed as a true record.

Business: Vehicle Activated Sign in North Grimston: Insurance

It was agreed to accept Gallagher's quotation dated 15<sup>th</sup> November 2021 for a ATG Community Scheme Policy with a premium of £218 per year.

Roads:

Members received a copy of North Yorkshire County Council Highways Officer's letter dated 28<sup>th</sup> September 2021 noting his comments regarding:

Mill Lane, Birdsall, Church Lane, Birdsall, Burythorpe road junction, Toisland Farm and the road/diversion signs.

The Clerk was asked to write to the Highway's Officer to notify him that the Post Office are refusing to deliver to Toisland Farm due to the continued bad state of the road.

Fly Tipping:

The lane near Grimston Fields Farm had been cleared but rubbish had now been tipped in the green lane between the Langton/North Grimston road and the B1248 and Mr. Simon McMillan is dealing with it.

Precept: Following discussion it was agreed to a Precept of £400 for the financial year 2022/23.

ness: Insurance Premium: Mr. Toby Lee very kindly offered to refund the Parish Council for the premium on the new Community Scheme Policy. Mr. Lee's offer was gratefully accepted with many thanks for his generosity.

Mul. Road verge: The Clerk was asked to notify North Yorkshire County Council Highways that this verge was still a danger to vehicles.

DeFibrillators: It was agreed to insure the two defibrillators under the new Policy. Mr. Simon McMillan to find out their value.

Mr. C. Stamp, 3 Salents Cottages, Birdsall: It was noted that Mr. Stamp had tarmaced and fenced the verge in front of this property. The Clerk was asked to bring this matter to the attention of the Highways Department.

Ludditt Road Grit Bins: It was thought these had been stored at Wharram Grange Farm and this will be looked into.

Village Notice Boards: The 2 boards in Birdsall and the 1 in North Grimston require painting. It was agreed to accept Mr. Mick Milner's offer to paint these for £60 each with Birdsall Estate, Company Limited providing the paint.
