Discharge of Conditions 21/01499/FUL

Approval in part of Application 21/01499/FUL on 18 March 2022 is subject to two planning conditions that require discharge – Conditions 04 & 07.

Condition 04 - Litter Management Plan

The operators and staff of the premises currently trading as Dogh Café will carry out regular litter patrols of the area adjoining the café during operational hours, collecting any litter that has been dropped on the ground or has blown off the picnic benches.

The tables will be cleared as soon as possible after customers have completed their meals to prevent litter blow in the first place.

There is a public litter bin situated on the Village Green close to the café. When this is near to overflowing, as occasionally occurs, the operators and staff will remove surplus litter from the bin and deposit this in their own commercial bins for collection by the Local Authority on the designated day.

Condition 07 - Safety Measures for Outdoor Seating

In accordance with Condition 02 of the approval to Application 21/01499/FUL, the two picnic benches sited directly in front of the building, one on each side of the central entrance, as shown on approved Drawing PL 04 Rev A dated 09.02.2022, shall not project more than 1.8 metres from the front elevation with a maximum width of 1.5 metres.

The operators of the café and its staff will ensure that the picnic benches will not be moved outside these defined limits so as to avoid encroaching onto the adjacent section of service road. The operators and staff will also seek to ensure that the belongings of seated customers do not encroach into the service road or interfere with the flow of passing traffic on the service road. By placing appropriately worded notices, the operators will seek to prevent the picnic benches being used by the general public outside business hours of 08:00 to 18:00 Monday to Saturday and 08:00 to 17:00 on Sundays and Bank / Public Holidays as approved under Application 21/01590/73A.

The operators of the business will advise suppliers not to park delivery vehicles adjacent to the picnic benches in order to minimise interruption to the flow of local traffic on the service road and to prevent conflict with seated customers.
